A summary of the report from Wine Australia looking at all three inland regions can be found on page 3 of this edition of Vine Chat. Growers interested in looking at the entire report in detail can obtain this from Wine Wine Australia's Facts database at www.wineaustralia.com - simply do a guick search for all free products from the Wine Information Dashboard and download the spread sheet titled 2012 Winegrape Purchases: Price Dispersion.

The report which covers the majority of winegrape Australia includes purchases made within the Calculated Average Purchase Value for regions by variety and the distribution of tonnages across the price spectrum for region by variety at the national level.

Analysis of the major varieties shows some minor declines in prices, while a majority of varieties held their price even increasing on the previous year. Importantly these figures do not account for the average production levels declining in 2012.

The table (below) shows the change from 2011 to 2012 in terms of the highest percentage volume of purchased grapes surveyed in the Riverina in 2012. For more detail please refer to page 3 (yellow box indicates decline).

The 2012/13 WGMB spray diaries have 2012/2013 recently been posted to all growers. All Riverina levy paying grape growers should have received a copy of the diary. This will ensure that you have access to the AWRI 'dogbook' listing of registered agrochemicals and a hard copy diary to keep on farm to comply with current EPA regulations.

If you currently keep all records online we suggest you use the Board diary as a shed



tool to initially record information for transposing into your online system.

The diary is again in a separated format comprising of a Spray booklet, containing the AWRI dogbook, calibration sheets and general information and a Diary record insert, containing record sheets for 24 spray entries. - Board met with Local Association The representatives to discuss industry concerns.
- Reminders of outstanding accounts were sent to growers in relation to the statutory fees and charges for 2012. Accounts were due 30th June 2012.
- The Board was formally advised by NSWDPI that it cannot use growers funds to fund any fruit fly activities in the region.

The site has a capacity 30,000 tonnes, it closed in 2010. If this level is required by the new owners the region is set to benefit.
